

**Regulations for the 24th Science Picnic  
of POLISH RADIO and the COPERNICUS SCIENCE CENTRE  
9 May June 2020, Warsaw**

**Article 1  
General Provisions**

1. These regulations (hereinafter referred to as the "Regulations") have been developed by Polskie Radio S.A., seated in Warsaw, Al. Niepodległości 77/85, and the Copernicus Science Centre, seated in Warsaw, Wybrzeże Kościuszkowskie 20, (hereinafter referred to as "the Organizer") on the basis of the provisions of the Civil Code (Journal of Laws of 2019, item 1145, consolidated text as amended) and the Act of 20 March 2009 on Mass Event Security (Journal of Laws 2018, item 1870, consolidated text as amended).
2. The 24<sup>th</sup> Science Picnic of Polish Radio and the Copernicus Science Centre, hereinafter referred to as the "Picnic", will take place on 9 May 2020 in Warsaw and is a mass event within the meaning of the Act of 20 March 2009 on Mass Event Security.
3. The Picnic will be held at the "PGE Narodowy" Stadium in Warsaw, Al. Księcia J. Poniatowskiego 1.
4. A Participant of the Picnic is any person in the area where the Picnic is organised (hereinafter referred to as a "Participant"). The Picnic area is separated and marked on site plans made available to Participants in the information tents (hereinafter referred to as the "Picnic Area").
5. These Regulations shall be applicable to all Participants present within the Picnic Area during the Picnic. Every Participant present within the Picnic Area during the Picnic shall abide by the provisions of these Regulations as well as the Regulations of the "PGE Narodowy" Stadium, which are attached in Appendix No. 1 hereto. In case of discrepancies between regulations, the provisions of these Regulations shall prevail.
6. The purpose of these Regulations is to assure the safety of the Picnic by means of specified rules of conduct of the persons present at the Picnic, and to ensure their safe use of the Picnic Area and devices located within it. The participant should also follow the instructions provided by the exhibitor responsible for the show in question.
7. Entering the Picnic Area shall mean acceptance of the provisions of the Regulations of the "PGE Narodowy" Stadium, that is the Appendix 1 to these Regulations.
8. Within the Picnic Area, there shall be information points and medical points with rescue ambulances on duty. These points are marked on the map of the area as indicated in the legend.

**Article 2  
Rights and Obligations of Participants**

1. Entrance to the Picnic Area during the Picnic shall be free of charge and available to all persons subject to the provisions of paragraph 8 of this Article.



2. Minors shall be allowed to participate in the Picnic under the sole responsibility of their adult custodians.
3. All Participants taking part in the Picnic shall be obliged to behave in a manner that does not pose threat to the safety of other persons, in particular to respect the occupational health and safety regulations, Fire Safety Instructions and provisions of these Regulations.
4. The Participants and all persons present at the Picnic Area shall be obliged to obey order-maintaining instructions issued by the Organiser and by the order-maintaining and information-providing services established by the Organizer.
5. It shall be prohibited within the Picnic Area for the persons participating in it to bring and hold arms and ammunition or other dangerous items, explosives, pyrotechnic products, materials posing a fire hazard, alcoholic beverages, intoxicating substances, psychotropic agents and other similar substances.
6. It shall be prohibited within the Picnic Area to conduct any trade, commercial, promotional, advertising activities or political agitation without consent of the Organiser.
7. Smoking and the use of electronic cigarettes are prohibited in the Picnic Area.
8. The following persons shall not be allowed to enter the Picnic Area:
  - a) a person that is clearly under the influence of alcohol, intoxicating substances, psychotropic agents or other substances with similar effects,
  - b) a person behaving in an aggressive or provocative manner or causing threat to public safety or order in another way,
  - c) a person who has been prohibited by a binding court order from entering a mass event, or ordered to refrain from being on sites where mass events are conducted, pursuant to art. 6 pt. 2 of the Act of 26 October 1982 on proceedings in cases of minors (Journal of Laws Dz. U. of 2018. item 969, consolidated text as amended)
  - d) refusing to undergo the activities referred to in the Act on the Safety at Mass Events of 20 March 2009
9. In addition, it is prohibited to:
  - a) enter or pass through objects, temporary fencing and devices not intended for free access;
  - b) enter service rooms, pass through places not intended for the public, fenced off or otherwise separated;
  - c) throw any kind of objects,
  - d) enter with two-wheeled vehicles;
  - e) enter with electric scooters,
  - f) proclaim and display slogans with obscene, vulgar and racist content, calling for international, religious, social conflict, etc.
10. If the order-maintaining services of the Picnic Organiser and individuals responsible for the Picnic conclude that the provisions in paragraphs 5-9 have been violated are authorised to remove such individuals from the Picnic Area.
11. In the event of noticing a fire or another threat to life, health or property, the Participants and persons present within the Picnic Area should:
  - a) immediately notify the order-maintaining or information-providing services,
  - b) avoid panic,



- c) abide by all instructions of the order-maintaining and information-providing services,
- d) leave the Picnic Area in a calm manner.

**12.** The Organiser reserves the right to remove any Picnic Participant acting in a coarse manner or harassing other persons during the Picnic. Participants at the Picnic are required to abide by the rules of respecting public property, respecting green areas, and not littering.

**13.** Participants in the Picnic are required to comply absolutely with the requests and recommendations of the order-maintaining and information providing Services of the Picnic Organiser and individuals responsible for the Picnic. These recommendations may concern:

- a) an order to leave the Picnic premises in connection with an existing danger, specifying particular means of behaviour (pointing out the nearest exit point from the Picnic Area),
- b) an order to behave in a strictly defined manner so as to ensure the safety of the participants of the Picnic,
- c) refusal of access to those places on the premises which are not intended for the public, in particular this applies to maintenance and storage rooms, offices and other organization-related locations, stages, technical support room, sound room, back room, etc.

**14.** The order-ensuring and information-providing services of the Organiser of the Picnic shall be authorised to:

- a) verify and confirm the right of specific individuals to participate in a mass event, and in the absence of such a right to summon said individuals to leave the mass event;
- b) ask to see the ID cards of individuals in order to ascertain their identity;
- c) inspect the content of the baggage and clothing of individuals in the event of a suspicion that individuals are bringing in or are in possession of the objects described in article 8 paragraph 2 of the Act on Security at Mass Public Events, in other words weapons or other dangerous objects, explosive materials, pyrotechnical materials, materials that pose a fire hazard, alcoholic beverages, intoxicating substances, psychotropic agents and other similar substances.
- d) issue order-maintaining instructions to individuals disturbing the public order or behaving in a way inconsistent with the regulations for the mass event or the regulations of the venue (stadium), and in the event those instructions are not followed, to summon said individuals to leave the mass event
- e) to apprehend individuals posing a direct threat to the property entrusted for protection or committing prohibited acts, for the purposes of prompt turnover to the Police.

**15.** In the event of disputes not regulated by these provisions, decisions are made by the Organizer or the Organizer's wardens.

### **Article 3** **Final provisions**

- 1.** The Organiser reserves the right to determine and modify the course of the Picnic and determine and modify the Picnic programme in terms of content and duration in the case of force majeure events, including but not limited to the right to immediately terminate the Picnic.
- 2.** The Organiser shall not bear the responsibility for the effects of force majeure. Force majeure shall be understood as an event that is beyond the control of the Organiser and that causes that the fulfilment of obligations is impossible or may be regarded as impossible due to the



circumstances. Force majeure shall mean in particular: weather conditions preventing or hindering the performance of obligations by the Organiser, breakdowns or disturbances in the operation of power supply equipment.

3. The Organiser shall not bear the responsibility for any items left within the Picnic Area.
